



UPHA CLASSICS INCENTIVE SADDLEBRED TWO YEAR OLDS IN TRAINING & YEARLING SALE Thursday Evening, November 18th, 2010

The 7th Annual UPHA Classics Incentive Sale will be held in conjunction with the UPHA/American Royal National Championship Horse Show in Kansas City, MO, on November 18th, 2010, at approximately 9:00 p.m. in Hale Arena.

The purpose of this sale is to raise incentive money to be paid back on the national level in the UPHA Classics program, offering breeders a viable marketplace for their Two Year Olds and Yearlings. Two Year Olds purchased through the 2010 sale will be eligible as three year olds in 2011, to compete for the incentive money raised from this sale. Yearlings purchased through the 2010 sale will be eligible as three year olds in 2012, to compete for the incentive money raised from this sale. The culmination will be at the 2011 and 2012 UPHA/American Royal National Championship Horse Shows, when bonus money will be awarded to the eligible horse that placed highest in the following UPHA Classics Championships:

**UPHA Three Year Old Five-Gaited
UPHA Three Year Old Three-Gaited
UPHA Three Year Old Fine Harness
UPHA Three Year Old Park Pleasure**

Prize money awarded in the UPHA Classics Incentive program so far totals \$140,000, with 10% of that total being paid back to the original consignors!

Eligible Two Year Olds and Yearlings for the program automatically include those purchased through the UPHA sale. Yearlings will be presented through the sale in hand, and all Two Year Olds will be presented through the sales arena, in harness or under saddle, as they would be shown under United States Equestrian Federation (USEF) guidelines.

Entries close October 1st, 2010. A non-refundable initial entry fee of \$500.00 payable to UPHA Classics Incentive Sale is required. Original registration papers and a completed entry blank must also be enclosed. Ten Percent (10%) of the bonus money paid at the 2011 and 2012 UPHA/American Royal National Championship Horse Shows will be awarded to the consignors of the 2010 sale entries.

UPHA Classics Incentive Sale
Featuring Two Year Olds In Training & Yearlings
Consignor's Contract

By entering any horse(s) in the UPHA Classics Incentive Sale, and by signing the consignment entry form attached to these terms, the Consignor agrees to the following terms and conditions:

1. The Consignor agrees that after having consigned a horse to this sale, he will arrange to have the horse at the place of sale in proper time, and he will not dispose of it by private sale, either prior to or during the progress of the sale, or any time the horse is on the sale grounds, and he hereby contracts to pay the UPHA Classics Incentive Sale a withdrawal fee of ten percent (10%) of the actual selling price if this agreement is violated. Once the horse is on the grounds of the sale, the horse must be sold through the sales ring.
2. The consignor must notify the UPHA Classics Incentive Sale within 24 hours if the horse develops a serious injury or illness after its consignment to this sale which impairs its suitability for sale. Upon such occurrence, the Consignor must provide to the sale a signed statement from a licensed veterinarian which states the date the animal was examined for the condition, the specific condition of the animal, and states an opinion to a reasonable degree of scientific or medical certainty that the animal is suffering from serious injury or serious illness which renders the horse unfit for transportation and sale. The UPHA reserves the right to have any consigned animal examined by its authorized veterinarian and reserves the right to refuse any entry and to withdraw any horse from the sale if UPHA deems the horse to be unfit for sale.
3. Animals consigned to the UPHA Classics Incentive Sale are entirely at the risk of the Consignor until sold and paid for in full. The Consignor warrants that he has good title to the horse, free and clear of any liens and encumbrances, and the Consignor warrants that all information set forth herein is true and correct.
4. No reserves will be allowed at the UPHA Classics Incentive Sale.
5. A commission of ten percent (10%) on the highest bid and the ASHA transfer fee will be charged to the Consignor on each entry.
6. A stall will be provided to each entry; however, there will be no first bedding and all bedding and feed charges will be the responsibility of the Consignor.
7. Only the first forty (40) consignments will be accepted.
8. The UPHA is authorized to decline any bid by a person who has defaulted on former purchases, or by any person who the UPHA determines is not a reliable or responsible party.
9. A Coggins (Equine Infectious Anemia) Test taken within twelve (12) months prior to sale is required. A health certificate is also required, stating that examination was made within the past thirty (30) days and revealed the animal to be free from symptoms of any infectious disease or exposure thereto, and it shall include any tests that have been conducted as well as all vaccinations.
