



UPHA CLASSICS INCENTIVE SADDLEBRED TWO YEAR OLDS IN TRAINING & BROODMARE SALE November 20th, 2009

The 6th Annual UPHA Classics Incentive Sale will be held in conjunction with the UPHA American Royal National Championship Horse Show in Kansas City, MO, on November 20th, 2009.

The purpose of this sale is to raise incentive money to be paid back on the local and national levels in the UPHA Classics program, offering breeders a viable marketplace for their Two Year Olds. Two Year Olds purchased through the 2009 sale will be eligible as three year olds in 2010, to compete for the incentive money raised from this sale. The culmination will be at the 2010 UPHA American Royal National Championship Horse Show, when bonus money will be awarded to the eligible horse that placed highest in the following UPHA Classics Championships:

**UPHA Three Year Old Five-Gaited
UPHA Three Year Old Three-Gaited
UPHA Three Year Old Fine Harness
UPHA Three Year Old Park Pleasure**

Eligible Two Year Olds for the program automatically include those purchased through the UPHA sale. All Two Year Olds will be presented through the sales arena, in harness or under saddle, as they would be shown under United States Equestrian Federation (USEF) guidelines.

For the Broodmare section of this sale, the mare must be a World Champion, Reserve World Champion or the dam of a World Champion or Reserve World Champion. Embryo transfer mares will be accepted if they are carrying a foal from a mare that meets these criteria. The resulting foals will be eligible for the UPHA Incentive Fund prize money in their Three-Year-Old year.

Broodmares must be declared in foal by the entry closing date and be reconfirmed in foal 1 week prior to the date of the sale. A Veterinarian's certificate confirming pregnancy must accompany the entry and the updated confirmation must be presented with the mare at sale time.

Entries close October 9th, 2009. A non-refundable initial entry fee of \$500.00 payable to UPHA Classics Incentive Sale is required. Original registration papers and a completed entry blank must also be enclosed. Ten Percent (10%) of the bonus money paid at the 2010 UPHA American Royal National Championship Horse Show will be awarded to the consignors of the 2009 Two Year Olds.

UPHA Classics Incentive Sale
Featuring Two Year Olds In Training & Broodmares
Consignor's Contract

By entering any horse(s) in the UPHA Classics Incentive Sale, and by signing the consignment entry form attached to these terms, the consignor agrees to the following terms and conditions:

1. The consignor agrees that after having consigned a horse to this sale, he will not dispose of it by private sale, either prior to or during the progress of the sale, or any time the horse is on the sale grounds, and he hereby contracts to pay the UPHA Classics Incentive Sale a withdrawal fee of ten percent (10%) of the actual selling price, if this agreement is violated. Once the horse is on the grounds of the sale, the horse must be sold through the sales ring.
2. The consignor must notify the UPHA Classics Incentive Sale within 24 hours if the horse develops a serious injury or illness after it's consignment to this sale which impairs it's suitability for sale. Upon such occurrence, the consignor must provide to the sale a signed statement from a licensed veterinarian which states the date the animal was examined for the condition, the specific condition of the animal, and states an opinion to a reasonable degree of scientific or medical certainty that the animal is suffering from serious injury or serious illness which renders the horse unfit for transportation and sale. The UPHA reserves the right to have any consigned animal examined by their authorized veterinarian.
3. Animals consigned to the UPHA Classics Incentive Sale are entirely at the risk of the consignor until sold and paid for in full.
4. No reserves will be allowed at the UPHA Classics Incentive Sale.
5. A Commission of ten percent (10%) on the highest bid and the ASHA transfer fee will be charged to the consignor on each entry.
6. A stall will be provided to each entry, however there will be no first bedding and all bedding and feed charges will be the responsibility of the consignor.
